10:30 Introduction of AI in accounting - what is worthwhile and what is not?

AI in accounting has extremely high potential. However, the topic of AI in accounting is associated with many dimensions, which makes a stringent decision to introduce it very difficult. For example, the AI's differentiation in the degree of independence of its actions. Or the distinction between Analytical AI and GenKI/ChatKI. Or the difficulty of auditing the decision-making of an autonomous AI in accounting. Accordingly, the decision-making process for the introduction of AI in accounting is associated with a high level of initial uncertainty.
